LISR reviews reference works, dissertations, research methods texts, computer software, and professional literature covering the research process and applications of research. Views expressed are those of the reviewers and do not necessarily reflect the views of the Editorial Board or publisher.

The main focus of the review is an assessment of the work and its relation to others in the field. What is the purpose of the work, has that purpose been achieved, and how has that purpose been achieved? Summarizing the scope, arrangement, and special features of the work may aid in your assessment. Please try to compare the work to other relevant works. Also mention the basis for the author's authority in writing the book.

The Review Editor retains the right to make slight editorial changes, as necessary, in submitted reviews.

#### SUBMISSION FORMAT

Submit a Word document via the EES system, at <http://ees.elsevier.com/libinf/>. You will have to "register" as an author (top menu bar) before submitting the review ("submit a paper"), and during submission you will enter the title of the reviewed item, and then you will be prompted to identify your submission as a book review. #### STYLE

The review should contain three sections in this order: the bibliographic citation of the work reviewed, the review itself, and identification of the reviewer. If there are references, they should be the last item and should be preceded by the word "References".

*Bibliographic citation for the reviewed item:* This should conform to the format shown at the top of this page.

*Reviewer identification:* Include your name as you wish to have it listed and your place of employment, including street address, city, state, and ZIP code, and e-mail address.

*Quotation guidelines:* Please include page numbers for all quotation from the work being reviewed. Manuscripts and reviews in LISR must conform to the current edition of the *Publication Manual of the American Psychological Association*. If you refer to another work in the review, please provide complete bibliographic information for it in a section: References, following the review, using the APA guidelines. Unpublished references should not be treated as reference notes, but listed in the same format as published references. Examples follow:

Journal article:

Weick, K.E. (1989). Theory construction as a disciplined imagination. *Academy of Management Review*, 14, 516-531. (Note: If each issue in a volume begins with page 1, then the issue number should be given as 14(1), 34-52.)

Book:

Chapter in a book:

Buckland, M.K., & Gathegi, J. (1991). International aspects of LIS research. In C.R. McClure & P. Hernon (Eds.), *Library and information science research: Perspectives and strategies for improvement* (pp. 63-71). Norwood, NJ: Ablex.
